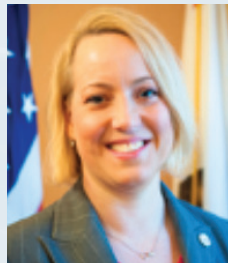

Message From Our Chair

Thank you for taking the time to read our first newsletter of 2017. We started publishing our newsletter to keep stakeholders informed about the Board of Chiropractic Examiners (Board/BCE) and our current activities. This January, as we do every January in accordance with the Chiropractic Initiative Act of California, we had a new election of officers. I am privileged to be the new Chair of the Board, and proud to be working with Mr. Frank Ruffino as Vice Chair, Dr. Sergio Azzolino as Secretary, Dr. Julie Elginer, Dr. Dionne McClain, Dr. John Roza and Dr. Corey Lichtman.

I am a second-generation chiropractor and have five chiropractors in my family. This means that chiropractic is not just my career, it is my way of life, and I am passionate about the profession and our patients. I am fortunate to work with my fellow Board members and staff to protect the health, welfare, and safety of the public through licensure, education, and enforcement in chiropractic care. My focus this year is to continue our collaborative work with our stakeholders, comprised of chiropractic colleges, licensees, students, and continuing education (CE) providers, to promote our highest level of public protection.

To achieve our goals, the Board has made steady progress in many areas:

- The Board recently collaborated with DCA’s Office of Professional Examination Services to conduct an Occupational Analysis (OA). The purpose of the OA is to define the chiropractic practice in California in terms of actual job tasks that newly licensed chiropractors must be able to perform safely and competently at the time of licensure. The Board recruited licensees to serve as Subject Matter Experts (SMEs) at OA workshops. SMEs were essential to this process as they represent a diverse group of licensees who provide current input into the chiropractic profession. The results of the OA serve as a basis for developing an examination for chiropractic licensing in California.
- Additionally, the Board and the DCA’s Office of Professional Examination Services are currently updating our Law and Professional Practices exam (jurisprudence exam). We are currently seeking volunteers for our upcoming jurisprudence exam workshops, and I highly encourage you to serve as a SME. The Board pays an honorarium to SMEs who participate in the workshops (\$100/per day). Our workshops

last two days and are conducted from 8:30 a.m. to 5 p.m. each day. Participants who travel 50 miles or more each way to workshops are reimbursed for travel expenses. Airfare is prepaid by the Board. Furthermore, the Board will reimburse participants for costs of hotel, meals, mileage, and other expenses up to specified limits as explained in the *Travel Pocket Guide*. Participants will also receive 16 hours of general CE credit for participating in our two-day workshop. Licensees, if you are not sure about your qualifications to become a SME, you should think twice! We know you have gone through a comprehensive academic and clinical training, in addition to a successful completion of national and state examinations. Your expertise and professional opinion matter! If you would like to obtain more information or would like to submit your name for consideration as a SME, please contact Brianna Lauziere at (916) 263-5355, ext. 5373, or at brianna.lauziere@dca.ca.gov.

- Pursuant to the California Code of Regulations, Section 361 (g) (1–15), the Board encourages licensees to attend full Board meetings and earn a maximum of four hours of CE credit per renewal period. Your attendance at a Board meeting would include the hearing of cases related to petitioners seeking the reinstatement of revoked licenses or early termination of probationary licenses. Attendance at meetings is monitored and confirmed by the Board staff.
- The Board’s primary function is ensuring compliance with California’s chiropractic laws and regulations. This enables consumers to feel confident that their Doctor of Chiropractic is trained and qualified to provide a safe and effective treatment. The Board is currently considering the following legislative and regulatory proposals:
 - **Application for Licensure (California Code of Regulations, Section 321):** This regulation would amend the application for licensure to comply with new state laws. Among other provisions, this proposal would expedite the licensure process for veterans, active military service members, and their families.
 - **Uniform Standards for Substance Abusing Licensees:** This regulation would enact guidelines for the monitoring and rehabilitation of licensees

who have been found to have a drug and/or alcohol addiction.

- **Mandatory Cardiopulmonary Resuscitation (CPR) – Certification for all Licensees:** This regulation would require all licensees to maintain current CPR certification or basic life support (BLS) as a condition of licensure.
- **Revisions to the Board’s Disciplinary Guidelines:** The Board is revising its disciplinary guidelines to ensure that licensee discipline is appropriate and consistent. This will streamline the enforcement process and ensure greater consumer protection.

More information about our proposed regulations can be found in the regulations update section of this newsletter.

- The Board recently reviewed our previous Strategic Plan, and developed a new plan for 2017-2019. This three-year plan specifies the goals and objectives that will allow the Board to continue its mission to protect the health, welfare and safety of the public through licensure, education, and enforcement in chiropractic care. - We are actively working on outreach efforts with stakeholders, comprised of chiropractic professional associations, Board-approved schools or colleges, providers, and others who express interest in the strategic direction of the Board. We believe that it is important to communicate with consumers, licensees, governmental entities, and stakeholders about the current and evolving practice of chiropractic and the regulation of the profession. The Importance of Renewing Your License in a Timely Manner

Over the years, Board staff have noticed a pattern of activity between licensees and the BCE, which occurs at the beginning and end of every month. The situations vary, but the end result is almost always the same: Your license has or is coming close to expiring and you need to renew as soon as possible or risk the consequences of practicing on an expired license. Forgetting to renew, while common, isn't the only reason licensees find themselves in this situation. Sometimes the renewal is submitted early but is returned to the licensee due to insufficient payment or a dishonored check; or the renewal is lost in the mail and is never received by the Board. In the case of insufficient or dishonored payments, licensees can always expect notification from the Board as long as a current address is on file; however, if the Board does not receive a payment, insufficient or otherwise, notification will only be sent after the license has expired. This is what makes routine verification important for licensees and employers, since it allows licensees to avoid delinquent fees and possible disciplinary action.

Reminders for License Renewal:

- Your license will expire on the last day of your birth month and must be renewed annually.
- Ensure that you have answered all questions and signed your renewal form before sending it in with the proper fees.
- Please make sure your practice address is current on the BCE website. If not, complete an address change form immediately (www.chiro.ca.gov/forms_pubs/add_change.pdf).
- If you have not received your license renewal form, you can visit the BCE website to print a copy (www.chiro.ca.gov/forms_pubs/replace_renewal.pdf).

Employers Urged to Routinely Verify Employees' Licenses

While it is ultimately the responsibility of DCs to keep their licenses up to date, the BCE strongly encourages employers to continually verify the license status of employees. As a team, the aim is to provide an environment in which you may provide safe and legal healthcare to the citizens of California.

Employers create such an environment in large part through the employment of licensed healthcare professionals. This makes employers vulnerable to the same pitfalls licensees share concerning license renewals and licensee status changes due to disciplinary actions. We've had many conversations with employers who have had to send their employees home because they did not realize a license was expired and only came across this information in passing. Such situations affect the business, the employee, and the patient, resulting in a negative outcome for all.

This becomes more of a problem when DCs are found to be practicing without a valid license. Not only would the DC be subject to possible disciplinary action, but a patient's insurance company could very well refuse payment on the grounds that an unlicensed DC was providing treatment at the time. The best way to avoid such situations is to routinely verify a DC license status on the Board website at www.chiro.ca.gov, especially during renewal time. Preventative measures like these will save a lot of headaches in the future for all parties involved and will help to maintain a safe and professional environment in which to serve the people of California.

To easily verify a license, visit www.chiro.ca.gov and click on the "License Search" button. Enter the name or license number, and the search will confirm if the individual is licensed. The search also has additional information, such as whether the licensee has disciplinary action pending, prior disciplinary action, or the licensee is on probation.

Did You Know?

- If licensees practice on an expired license, they may find themselves exposed to liabilities or sanctions for services conducted or billed while the license was expired. Medical, disability, and workers' compensation insurance companies are not required to reimburse DCs for compensation during a period of non-licensure.

Failing to renew a license in a timely manner or practicing with an expired license can have unintended consequences such as late fees in addition to the license renewal fee.

To help ensure that the Board issues a license in a timely manner:

An address should be kept current with the Board, as required by California Code Regulations Section 303—licensees are required to notify the Board in writing of any and all changes to the practice address, giving both the old and new address, within 30 days of that change.

Required continuing education should be completed within 12 months prior to a licensee's current renewal period.

- Chiropractic students are qualified to receive federal student loan assistance and DCs are authorized to be commissioned as health care officers in the armed forces (International Chiropractors Association: www.chiropractic.org/faq-chiro).

Options for Military Members and Their Families

The Board of Chiropractic Examiners offers the following services for members of the U.S. armed forces and their families:

- The Board will expedite applications submitted by applicants who served as members of the armed forces and were honorably discharged.
- The Board will expedite applications submitted by spouses, domestic partners, or those in other legal unions with an active-duty member of the armed forces.
- The Board will waive renewal fees and continuing education requirements if a licensee is called to active duty as a member of the armed forces or California National Guard, as long as written documentation is provided to the Board.

Regulation Update 2017

Regulation

The Board is actively working on three regulatory proposals, in various stages of completion.

Application for Licensure and Continuing Education Requirements

The regulation would amend the continuing education (CE) regulations to waive renewal fees, continuing education requirements, and other requirements for active-duty members of the U.S. military. Also, the regulation proposes to allow the Board to award up to 16 hours of CE credit to licensees who participate in the review and revision of the California Law and Professional Practices Examination.

In January, the Executive Director issued an extension to complete review of the package. The Board anticipates submission to the Office of Administrative Law in the spring of 2017.

Consumer Protection Enforcement Initiative (CPEI)

The regulation would add or amend 12 sections within the California Code of Regulations and establish stricter reporting and disclosure requirements by licensees and applicants. This regulation would also increase the Board's enforcement authority and access to critical information for use in investigations.

On May 19, 2016, the regulation package was approved by the Board. In the fall of 2016, the Department of Consumer Affairs (DCA) initiated a new regulation review process that CPEI was subject to.

The regulation package is currently under review with the DCA's budget office. The Board anticipates noticing the package in the spring of 2017.

Delegation of Authority to the Assistant Executive Officer

This proposed regulation would delegate authority to the Board's Assistant Executive Officer to execute specific enforcement actions and office operational functions in order to expedite the business of the Board, and to increase the health, safety, and welfare of consumers.

The regulation package is currently under development and the Board anticipates its submission to DCA for review in the spring of 2017.

Legislative

Previous Legislative Session

Senate Bill 1348 (Cannella) Licensure Applications: Military Experience (2016)

- Existing law provides for the licensure and regulation of various professions and vocations by boards within DCA. Existing law requires each board to inquire in every application for licensure if the individual applying for licensure is serving in, or has previously served in, the military.
- This bill is now effective and requires each board or bureau, with a governing law authorizing applicants to apply military experience and training towards licensure requirements, to post information on the board or bureau's website about the ability of applicants to apply their military experience and training toward licensure requirements.

How a DUI Can Affect Your License

Every day, individuals are arrested for DUI or DUI-related offenses. These individuals experience the embarrassment, expense, and stress of being arrested and charged with a misdemeanor or felony, depending on the circumstances under which they had been arrested. The majority of those arrested will accept the consequences of their actions, complete all court requirements, and move on with their lives. For others, including chiropractors, the situation is more complicated.

The Board considers a DUI to be substantially related to the practice of chiropractic care. The offense constitutes unprofessional conduct and therefore is punishable through disciplinary action imposed by the Board. It should be noted that each case is reviewed individually since the Board takes into consideration the final disposition of the case, the arrest records, court records, and the licensee's written response to the circumstances surrounding the event as well as prior convictions and/or discipline by the Board.

Upon final review of all information gathered, a determination will be made as to whether disciplinary action will be pursued or an administrative citation will be issued. If pursued, disciplinary actions remain on a licensee's public record indefinitely while administrative fines remain for a term of five years.

The disciplinary process, like a DUI conviction, is stressful, costly, and time-consuming. It is the hope of the BCE that chiropractors everywhere become aware of the far-reaching effect that a DUI can have on their lives, both professionally and personally.

EARN CE CREDIT FOR ATTENDING BOARD MEETINGS

Section 361 (g)(15) of Title 16 of the California Code of Regulations allows a licensee to earn a maximum of four hours of continuing education credit per renewal period for attending a full board meeting that includes the hearing of cases related to petitioners seeking the reinstatement of revoked licenses or early termination of probation. A petitioner may not earn any continuing education hours for attending a board meeting on the same day in which said petitioner's hearing is conducted. The attendance of a licensee at a board meeting under this subparagraph shall be monitored and confirmed by Board staff designated by the Executive Officer.
