This farewell interview highlights Dr. Elginer’s outstanding accomplishments and contributions to the Board.

How has your professional expertise applied to your role on the Board?

As a public member, I bring a different perspective to Board governance. My areas of expertise include public health, health policy, and management, including financial oversight, strategic planning, communications, and more. I developed these areas in academia, the private sector, and the nonprofit sector. When the Governor appointed me to this role almost five years ago, my intent was to strengthen our Board practices along these dimensions. Along with our outstanding staff, we have certainly done so in the following ways, including:

- In 2013 we created our three-year strategic plan, which served as a guidepost for our collective efforts. During the planning process, we involved stakeholders from the chiropractic colleges, subject matter experts, consumer advocates, professional associations, and more. We engaged with the people who would be most impacted by our strategic direction. We replicated this process in 2016 and have built in the expectation that this would be completed every three years moving forward.
- We created a legislative tracking manual that serves to clarify the process by which we will take a position on legislation. This allows for Board members and any interested stakeholder to understand how, why, and when we will consider acting on pending legislation, as well as the types of positions we will consider. This has been cited as a “best practice” within the Department of Consumer Affairs (DCA).

- We have improved our understanding of our fiscal position through more robust dialogue with our Executive Officer and DCA offices regarding our budget, pro-rata amounts allocated to the Board, and more. We are a Board that is mindful of our fiduciary responsibilities and how to maximize our resources.
- Finally, I developed and presented several training sessions for Board members, including parliamentary procedure best practices and maximizing social media.

The Board's mission is to protect the health, welfare, and safety of the public through licensure, education, and enforcement in chiropractic care. What makes its mission powerful for you?

The consumer protection mandate resonates strongly with me. It is our responsibility to ensure that patients have confidence in their chiropractic care. The professional associations and chiropractic colleges play a considerable role in the education of competent, qualified, outstanding doctors of chiropractic (DCs). Yet, the overall responsibility to ensure DCs are meeting licensure standards, have appropriate continuing education classes available, and are following the regulations and laws governing chiropractic care resides with the Board. Consumers deserve and demand it. During our Board and committee meetings, we discuss this consumer protection mandate, which is the highest priority for our Board members and staff. Our mission isn't hypothetical. We do our best to live it.

From your perspective, why is it important to inform the public and chiropractic licensees about our rules and regulations?

Any professional practice must evolve and grow as needed, and a Board that governs healthcare activities must be equally willing to help stakeholders understand the changing landscape. For an entity that is responsible for oversight, it is paramount that we conduct outreach to help licensees and consumers stay informed as to necessary changes. We publish them in our newsletter, discuss them at committee meetings, house them on our website, and send updates through social media.

At times, new rules and regulations around chiropractic care may seem obscure, but they are well thought-out and well-vetted before becoming final. I would love to see more stakeholders participate in the regulatory process. Concerned members can do so during the open comment period and by attending committee meetings where the

proposed regulations are being discussed. Our Board practices are designed for stakeholder input. It is the responsibility of the licensee and the public to take the initiative to engage.

Did you experience any major changes that impacted the Board during your term? If so, how did you address them?

I served both a vacancy, as well as my full four-year term. I am now serving in a grace period; a one-year time that is afforded the Governor's Office as they search for my replacement. When Dr. Azzolino, Dr. Dehn, and I were appointed in May 2012, we met with Governor Brown to discuss several items. We were aware of his pending reorganization plan to move the Board to DCA; thus, change was expected. Along with the staff, I would like to think we helped the profession and consumers see the wisdom in this organizational realignment. Change is incredibly difficult for people and the Board's move, although relatively seamless, necessitated the need for continuous communication. My perspective is that most licensees understand that our governing hasn't diminished as a result of the move.

Board vacancies are always to be expected but our intent was to minimize Board disruption, preserve Board culture and operating practices, and create a process in which new members could onboard as easily as possible. During my term, we had four new members join us—more than half of the Board. I think we developed a methodology for bringing new members on the Board and bringing them up to speed as efficiently and as effectively as possible.

I can honestly say that being on the Board has been incredibly rewarding and, dare I say, fun! I have tremendous respect for my fellow Board members and our Board staff. Over time, we have grown from colleagues to friends. The vast majority of the time, we agree on the path forward. In those instances when we disagree, we do so with tremendous professional respect. My time on this Board was truly my way of giving to the people of California through civic engagement. I do not benefit professionally or personally from doing so. I often tell people that the Board of Chiropractic Examiners is in a position of strength. As I depart in the next few months, I'm incredibly proud of that. I would like to think I played a small role in helping to create the current culture, practices, and policies for the people of California, public health community, and the profession of chiropractic.

Important Notices

■ Temporary License Renewal Fee Increase

Due to increased overhead costs and gradually declining revenue attributable to a decrease in our licensee population, the Board of Chiropractic Examiners (Board) faces an urgent need to temporarily increase the license renewal fee to maintain its solvency.

To address the fund decline, the Board Chair, Executive Officer, and staff worked with Legislature to get a temporary fee increase included in Senate Bill 547 (Hill, Chapter 429, Statutes of 2017), which was later signed by Governor Brown.

Effective January 1, 2018, SB 547 increases—for one year—the license renewal fee to \$300.

■ Long-Term Fiscal Planning

The Board's budget has become structurally unbalanced due to increasing overhead and declining revenue. To address this situation, the Board contracted with an accounting firm to conduct a comprehensive fee audit to determine what each fee should be, according to the actual cost to perform the corresponding service. The Board received a report recommending an appropriate fee structure that will ensure a balanced budget and prudent reserve for economic uncertainties.

Earn CE Credit: Attend Our Board Meeting

Section 361(g) (15) of Title 16 of the California Code of Regulations allows a licensee to earn a maximum of four hours of continuing education (CE) credit per renewal period for attending a full Board meeting that includes the hearing of cases related to petitioners seeking the reinstatement of revoked licenses or early termination of probation.

A petitioner may not earn any CE hours for attending a Board meeting on the same day in which the petitioner's hearing is conducted.

The attendance of a licensee at a Board meeting under this subparagraph shall be monitored and confirmed by Board staff designated by the Executive Officer.

UPDATE: 2018 Regulations

Regulation

The Board of Chiropractic Examiners (Board) is actively working on four regulatory proposals that are in various stages of completion.

Application for licensure and continuing education (CE) requirements

The Board will amend the application for licensure to comply with new legislation that will assist agencies in identifying past or present members of the military and their spouses to expedite the licensure process for these individuals. Additionally, this proposed regulation would amend CE regulations to waive renewal fees, continuing education requirements, and other requirements for active duty members of the U.S. military. Also, the regulation proposes to allow the Board to award as many as 16 hours of CE credit to licensees who participate in the review and revision of the California Law and Professional Practices Examination.

On May 1, 2017, the Board received a disapproval letter from the Office of Administrative Law (OAL). The Board made necessary changes and submitted the rulemaking to the Department of Consumer Affairs (DCA) for final review. This proposal must be submitted to OAL by April 26, 2018.

Consumer Protection Enforcement Initiative (CPEI)

The proposed regulation would add or amend 12 sections within the California Code of Regulations (CCRs) and establish stricter reporting and disclosure requirements for licensees and applicants. The rulemaking would also increase the Board's enforcement authority and access to critical information for use in investigations.

The proposed regulation was submitted to DCA for initial review on September 7, 2017. Currently, the regulatory package is under review by DCA's Legal Affairs Division.

Delegation of authority to the Board's Assistant Executive Officer

The proposed regulation would delegate authority to the Board's Assistant Executive Officer to approve settlement

agreements for revocation, surrender, and interim suspension of a license, or allow the Executive Officer to delegate these functions to another designee.

The proposed regulation was submitted to DCA for initial review on September 7, 2017. Currently, the regulatory package is under review by DCA's Legal Affairs Division.

Mandatory cardiopulmonary resuscitation (CPR) certification for all licensees

The regulation will add a new section, CCR 371.1, that would require, as a condition of licensure and license renewal, all licensees to maintain current cardiopulmonary resuscitation (CPR) or basic life support (BLS) certification from specified entities approved by the Board. Additionally, licensees may earn two hours of CE credit for completion of CPR/BLS courses. The proposed regulation would also make technical and clarifying amendments for consistency and clarity.

On July 30, 2015, the package was approved by the Board. The regulation package is currently under development, and the Board anticipates its submission to DCA for review in spring 2018.

Legislative

Previous Legislative Session

Senate Bill 547 (Hill) — Chiropractors: License renewal fee (2017)

This bill increases, until January 1, 2019, the annual license renewal fee from \$250 to \$300 and requires the Board to submit a report to the appropriate policy and fiscal committees of the Legislature by July 1, 2018, regarding the status of the Board's fee and an update on the Board's plans for restricting its license fees.

The bill was signed into law on October 2, 2017.

IMPORTANT FACTS

Advertising chiropractic services

With the rapid growth of technology in our society, online advertising is becoming one of the most powerful marketing strategies licensees use to advertise their practice.

However, increased competition among licensees may spur confusing, misleading, or deceptive consumer advertising to secure a position in the market. Deceptive advertising can be based on either failing to disclose an item of importance or affirmatively mispresenting information.

Whether you choose to advertise your services online or through other avenues such as TV, radio, or signage, it's crucial that you understand and comply with the Board of Chiropractic Examiners' (Board's) rules and regulations to prevent deceptive advertising. Be sure your advertising is in compliance with the California Code of Regulations (CCR), Title 16, section 311, and the Business and Professions Code section 651.

CCR section 311 reads as follows:

Constructive educational publicity is encouraged, but the use by any licensee of advertising which contains misstatements, falsehoods, misrepresentations, distorted, sensational or fabulous statements, or which is intended or has a tendency to deceive the public or impose upon credulous or ignorant persons, constitutes grounds for the imposition of any of the following disciplinary penalties:

- (a) Suspension of said licensee's right to practice in this State for a period not exceeding one (1) year.*
- (b) Placing said licensee upon probation.*
- (c) Taking such other action, excepting the revocation of said licensee's license, in relation to disciplining said licensee as the board in its discretion may deem proper.*

It is common for the Board to receive complaints regarding the incorrect title of a licensee in advertisements. Please be aware that it is a violation of section 15 of the Chiropractic Initiative Act if, when advertising your practice, you do not use "D.C." (Doctor of Chiropractic) following the use of "Dr." The Board cannot provide legal advice or give direction regarding your advertising; therefore, it is recommended that you consult a private attorney for assistance in these matters.

Privacy risks of social media

Social media platforms present strong marketing opportunities for healthcare professionals. However, many licensees find themselves inadvertently breaching patient confidentiality and violating the Health Insurance Portability and Accountability Act (HIPAA). This is a serious issue throughout the nation as healthcare professionals are faced with potential risks of not complying with HIPAA on social media sites. Understanding these risks will help licensees stay in compliance and make the most of social media's benefits.

HIPAA requires all individually identifiable health information to be protected. With increasing regulatory enforcement through HIPAA audits, healthcare providers need to be careful about sharing or disclosing patient information through social media. Common violations by healthcare professionals include:

- Uploading photos of patients on social media networking sites, which can possibly lead to penalties and tighter regulatory scrutiny. Such an incident not only violates a patient's privacy but also demonstrates noncompliance with HIPAA.
- Unintentionally disclosing information that allows other community members to guess the patient's identity. Many providers may know that patients' names should not be revealed, but HIPAA privacy requirements go beyond protecting patients' names. As a result, licensees may be reprimanded by their state's licensing authority.
- Responding to negative reviews on ratings sites such as Yelp. Healthcare providers may inadvertently share personal details about a patient's treatment or reveal diagnostics as they try to rebut criticism.

Social media platforms are a great tool to expand your practice, connect with patients, and interact with the chiropractic community. Be sure to do your own research when managing your social media interactions. Doing so will allow you to reduce privacy risks and take advantage of the benefits social media offers.

Healthcare professionals should consider a risk-management approach:

- No matter which social media platform you decide to use, you should regularly monitor social media conversations for possible HIPAA violations.
- Be sure to do your own research before using social media to communicate with your patients. Familiarize yourself with HIPAA confidentiality requirements and understand how it protects patient privacy. The U.S. Department of Health and Human Services offers specific HIPAA guidelines for professionals on its website: <https://www.hhs.gov/hipaa/for-professionals/index.html>.
- Develop a social media policy in which your practice identifies how social media will be used, who in your office is permitted to use your practice’s social media accounts, and what types of information may be shared.
- Regularly train your employees on HIPAA compliance and your social media policy.
- Have a system in place to help you not only prevent but also react to a HIPAA noncompliance issue, and implement an appropriate corrective action immediately.

Keep in mind that complying with HIPAA goes a long way toward continuing a successful practice. Developing a social media office plan and implementing a risk management approach are effective and proactive ways to ensure that social media privacy risks are minimized.

Did you know?

The Board is authorized to issue a Letter of Admonishment (LOA) to a licensee for minor violations of any laws governing the practice of chiropractic in California.

The LOA is an enforcement tool that allows licensees to correct minor violations and does not adversely affect their license status.

If a licensee does not agree with the LOA, the licensee can contest the LOA and request an informal appeal. During the informal appeal, the licensee can discuss the LOA with the Executive Officer. Following the informal appeal, the Executive Officer must notify the licensee within 14 days and state if the decision was affirmed, modified, or dismissed.
