Unprofessional Conduct: Preventing Some Common Missteps

Professional conduct is the foundation for regulations governing Board of Chiropractic Examiners’ (Board’s) practitioners. Although we may recognize unlawful activities obviously violate professional conduct, we don’t always consider that unprofessional conduct also includes actions that cast the chiropractic profession in a negative light. Malpractice and behavior likely to endanger the public are prime examples of a broader interpretation of unprofessional conduct.

Whenever a malpractice settlement exceeding \$3,000 is reached between a practitioner and a patient, the Board is notified. Injuries precipitating malpractice suits range from broken and dislocated bones to strokes.

Malpractice is costly. It drains dollars and also undermines the integrity of a robust practice—not only for the practitioners affected but for all those within the profession. On a very real level, it involves unprofessional conduct.

Malpractice is avoidable, however. Chiropractors who ensure their staff members are appropriately trained and, when necessary, properly monitored, greatly reduce the risk of a malpractice suit. Many patient injuries occur when the chiropractor isn’t in the office and has delegated a relatively unqualified assistant to administer a complex patient procedure.

It is not uncommon for today’s chiropractor to engage other individuals to perform massage or other services, sometimes at a satellite office opened under the chiropractor’s name and license number. In some instances, the chiropractor

may not fully know the individuals until some illegal activity attracts the attention of the Board or other law enforcement agencies. As a result, respected chiropractors—including those with impeccable professional ethics—can find their practices damaged as surely as though the misconduct had been their own. More importantly, licensed chiropractors can be held accountable for the actions of their employees. While you may view this as unprofessional conduct by association, the bottom line amounts to unprofessional conduct just the same.

Practitioners can avoid being associated with others with less scrupulous ethics. Chiropractors can adopt the straightforward precautions most employers use by verifying the names of prospective employees against arrest, citation, and warrant information available at any local court house. When hiring new staff, chiropractors should also retain employee applications, check references, and keep current information on anyone with access to patients or patient files.

If a chiropractor must be away from the office for extended periods of time, he or she should assign supervision of a new employee to a trustworthy staff member, especially at an off-site facility. Chiropractors should pay particular attention to the operation hours at a satellite office—suspicious or unauthorized hours usually indicate potential illegal activity.

Take the necessary time and precautions at the beginning, and then avoid possible unprofessional conduct situations. It can save you and your practice money and its reputation in the long run.

Check the License

The Board of Chiropractic Examiners (Board) advises consumers to check the license of any individual claiming to be a chiropractic doctor.

A properly licensed chiropractic doctor has completed comprehensive academic and clinical training, passed national and State examinations, and completed a background check before the Board will issue a license. Chiropractic doctors must renew their license annually and post their license in plain view for consumers to see.

You can easily verify a license by checking our website at www.chiro.ca.gov and clicking on "License Search." Enter the name or license number, and the search will confirm if the individual is licensed. The search also has additional information, such as whether the licensee has a pending disciplinary action or prior disciplinary action, or whether his or her license is on probation.

* As used in this summary, the term "accusation" is a formal document that notifies a licensee of the agency's charges against the licensee and that requests a disciplinary order. The licensee is entitled to contest the charges in a formal hearing before an administrative law judge. An accusation is usually resolved by an agency decision following such a hearing or by an agency decision pursuant to a settlement agreement. Often there is a considerable period of time between the date of filing an accusation and the resolution of the accusation.

Earn Continuing Education Credit for Attending Our Board Meetings

Section 361(g)15 of Title 16 of the California Code of Regulations of the Board of Chiropractic Examiners' (Board's) regulations allows a licensee to earn a maximum of four hours of continuing education (CE) credit per renewal period for attending a full Board meeting that includes the hearing of cases related to petitioners seeking the reinstatement of revoked licenses or early termination of probationary licenses. A petitioner may not earn any CE hours for attending a Board meeting on the same day in which said petitioner's hearing is conducted. The attendance of a licensee at a Board meeting under this subparagraph shall be monitored and confirmed by Board staff designated by the Executive Officer.

Recently Enacted Laws and Regulations

- In 2011, a comprehensive overhaul of the continuing education and annual license renewal regulations was adopted, which increased the annual hourly continuing education requirement from 12 to 24 hours, expanded continuing education course selections, and clarified the license renewal requirements as they relate to the changes in continuing education (California Code of Regulations, Title 16, §§ 360–366 and 370–371).
- This same year, the Board of Chiropractic Examiners (Board) adopted fingerprint regulations requiring electronic fingerprint

- submission from all licensees and applicants who do not have electronic fingerprint records on file with the Board. This regulation ensures that the Board receives notification of all criminal convictions by chiropractic licensees and applicants from the Department of Justice and Federal Bureau of Investigation (California Code of Regulations, Title 16, § 321.1).
- In 2012, an informed consent regulation was adopted requiring doctors of chiropractic to inform their patients of proposed procedures that present a material risk and obtain their verbal and written informed consent

Continuing Education

How many hours of continuing education (CE) do chiropractic doctors need annually to renew their license to practice chiropractic in California?

For renewals beginning June 1, 2013, and after, 24 hours of CE are required per year. Six of the 24 hours are mandatory from within the following categories:

- 2 hours Ethics and Law
- 4 hours in any one of or combination of the following topics:
 - Chiropractic Adjustive or Manipulation Technique
 - History Taking and Physical Examination Procedures
 - Proper and Ethical Billing and Coding



prior to providing treatment (California Code of Regulations, Title 16, § 319.1).

- This same year, a regulation enacting requirements and restrictions for use of lasers by chiropractors was adopted (California Code of Regulations, Title 16, § 302.5).
- In October 2013, Section 367.7 of Title 16 of the California Code of Regulations was repealed to alleviate an inconsistency between names of chiropractic corporations and noncorporate chiropractic businesses.
