Ms. Kristine Shultz, CCA, gave public comment opposing this bill.

MOTION: DR. STEINHARDT MOVED TO ACCEPT THE STAFF'S RECOMMENDATION IN ITS ENTIRETY SECOND: DR. TYLER SECONDED THE MOTION VOTE: 5-0 MOTION CARRIED
