### **Review of the Board Member Administrative Manual**

The Committee members discussed and recommended several amendments to the Board Member Administrative Manual and directed staff to make the changes to the manual for presentation at the next full board meeting for consideration.

#### Overview of the Board's Process for Tracking Legislation

Board staff and committee members discussed the effectiveness of the legislative tracking process used last year and agreed that the process was useful and successful.

Julia Bishop, DCA Legislative and Policy Analyst, recommended adding the new website address for California Legislative Information.

Mr. Ruffino suggested updating the front cover with the spine logo.

### Review of Enacted Legislation Requiring Rulemaking Action by the Board

Dixie Van Allen provided an overview of enacted legislation and advised the committee that the Board is preparing proposed rulemaking packages to comply with these laws which will amend Cal. Code of Regulations section 321 – Application for Licensure and section 364 – Exemptions and Reduction of Requirement.

Dr. Dehn requested that the Application for Licensure rulemaking proposal be added to the Licensing Committee Meeting agenda.

Mr. Puleo recommended addressing both of these amendments in one rulemaking package.

Dr. Elginer requested the rulemaking package to be presented for review at the next Government Affairs committee meeting.

Dr. Dehn requested clarification on the definition of "active duty" referred to in AB 1588.

### Review of the Implementation Plan for the Board's Strategic Plan

The committee reviewed Goals 1 through 4 and proposed numerous amendments to completion dates.

Dr. Elginer recommended that staff present a timeline of tasks, sorted by date, to present to the full board for consideration.

The committee members opted to review Goals 5 through7 at the next scheduled Govt. Affairs committee meeting.
