#### **Call to Order**

Dr. Dehn called the meeting to order at 12:35 P.M.

#### Roll Call

Dr. Roza called roll. All Board members were present at the locations specified on the Agenda.

#### **Approval of Minutes**

MOTION: DR. ROZA MOVED TO APPROVE THE MINUTES OF THE AUGUST 26, 2015 LICENSING, CONTINUING EDUCATION & PUBLIC RELATIONS COMMITTEE MEETING

SECOND: DR. LICHTMAN SECONDED THE MOTION

VOTE: 3-0 (DR. ROZA – AYE, DR. LICHTMAN – AYE, DR. DEHN – AYE)

#### **Review and Discussion of Continuing Education Audit Statistics**

Mr. Puleo shared statistics of non-complaint licensees found in CE audits from October 2013 to July 2015. Approximately 60 audits were conducted each month.

Dr. Dehn inquired about the Board's procedures when a licensee is found to be in violation with the CE requirements.

Mr. Puleo explained that if the chiropractor cannot produce records of CE credit they are sent to enforcement and may be issued a citation.

Dr. Dehn asked how long a chiropractor has to correct the deficiency.

Mr. Puleo stated that the chiropractor must complete the CE credits within a few weeks and provide proof of completion to Board staff. The chiropractor will most likely be audited again at their next renewal. First offenses typically result in a warning letter and subsequent offenses result in a citation.

Mr. Puleo shared that the Board has never had to open a formal complaint and file an accusation on a chiropractor for continuous violations with CE requirements.

Dr. Lichtman asked about the time frame for completing CE credits after a warning letter is issued.

Mr. Puleo explained that the Licensing Unit will allow the chiropractor to complete the CE within a few weeks of the audit. If course completion certificates are not received in a timely manner, a hold may be placed on their license which would prevent the licensee from practicing.

Dr. Dehn requested additional information to be presented at the next committee meeting on penalties for chiropractors who do not comply with the CE renewal requirements.

#### Review and Discussion on Strategic Plan Action Items

Dr. Dehn discussed Goal 1- Licensing and its relationship to the committee.

Mr. Puleo updated the committee on the Board's status regarding the conversion to the Breeze system. The Board continues to use CAS until the conversion takes place.

Dr. Dehn discussed Goal 3- Professional qualifications and continuing education. This is an ongoing project.

Mr. Puleo stated that the utilization of the CE provider task force will provide the Board with documentation justifying changes proposed in the rulemaking package.

The committee revised a timeline for goal 3.1- Establish provider review standards for continuing education providers. Action item 3.1.1- Define proficiency standards for CE providers has a new completion date of Q4 2015. Action item 3.1.2- Prepare proposed regulatory language in document and display changes in Q2 2016. Action item 3.1.3- Submit document to the Board for review and approval in Q2 2016. And action item 3.1.4- Complete

the regulatory process by Q2 2017.

Ms. Van Allen stated no changes have to be made to the strategic plan but the Board should be notified of the new dates.

Dr. Dehn stated that Goal 3.2- Develop a continuing education course auditing system will have to be revised once new regulations are put into place. This goal is currently completed with the laws that are in place.

Dr. Dehn explained that Goal 3.3- Evaluate effectiveness of compliance with CE regulations to ensure competency is on hold.

The committee has made an effort to provide CE providers with disciplinary information by creating a "Top 10 Violation" handout to distribute to chiropractors in hopes of lowering the rates of violations by licensees.

Mr. Puleo stated this goal has been completed but it is an ongoing goal to remind our CE providers to educate chiropractors of common violations to decrease infractions.

Dr. Dehn inquired about the process for distributing the "Top 10 Violation" handout.

Mr. Puleo shared that staff has emailed PDF versions of the handout to CE providers in the past.

Dr. Dehn suggested that the "Top 10 Violation" handout be provided to CE providers upon course approval and be included in course material for ethics courses.

Dr. Lichtman suggested an email blast to be sent quarterly to CE providers with a PDF version of the "Top 10 Violations" as a reminder to include this material in their course and encourage providers to distribute this document to course attendees.

Mr. Puleo stated that staff can create a template to send out regularly to CE providers.

Dr. Dehn discussed the travel restrictions with Goal 3.4- Establish and document protocols for ongoing communication with chiropractic oversight organizations to ensure consistent standards.

Ms. Kim DeWeese from California Chiropractic Association suggested the Board present and teach an ethics course.

Dr. Dehn discussed Goal 5- Public Relations and Outreach. She questioned the status of action item 5.1.2- contact DCA Office of Public Affairs for information on development of a BCE Communication Plan.

Mr. Puleo explained that the Government Affairs Committee completed this task. DCA's Public Affairs Office provided tips on navigating the Board's social media sites and networking. Julie Elginer, Dr. PH will provide social media training for the Board members at the next public Board meeting on January 28, 2016.

Dr. Dehn discussed Goal 5.2- Through the DCA Office of Publications, Design and Editing, develop consumer education materials about the Board. She stated that the Board continues to work with staff on creating new publications. We are currently in the process of completing a Licensee Guide and the winter 2015 Newsletter.

Dr. Dehn asked Mr. Puleo about Goal 5.3- Collaborate with DCA to optimize the Board's website.

Mr. Puleo mentioned there are limited changes that can be made to the website because DCA created templates for all Board related websites. We have the authority to make changes to the contents but cannot alter the appearance of the website.

Dr. Dehn suggested that the committee revisit the website matter in Q4 2016.

# Review and Discussion on Possible Revisions to the Continuing Education Regulations for Approving Continuing Education Providers- Update Regarding CE Provider Qualification Focus Group

Mr. Puleo announced that the first CE Provider Task Force is scheduled on November 5, 2015 from 12:30PM-3:30PM in Sacramento. The Board appointed DCA's SOLID Unit to facilitate the task force.

Dr. Dehn asked if a specific location has been selected.

Ms. Lauziere announced that the CE Provider Task Force will be held at the Department of Consumer Affairs HQ2 at 1625 N. Market Blvd, Sacramento, CA 95834 in the Sapphire Room #285.

Dr. Dehn inquired about the number of CE providers who were notified about the CE Task Force.

Ms. Lauziere stated that the Board mailed out invitations as well as emailed 180 CE providers. Additionally an email blast was sent to our online subscribers. Currently 6 CE providers have RSVP'd.

Mr. Puleo announced that there will be a second CE Provider Task Force held in Southern California early next year.

The committee members discussed possible dates and locations for the second task force.

Mr. Puleo stated the CE Provider Task Force will be considered a public meeting and announcements will be emailed to online subscribers and posted on the BCE website.

Dr. Dehn thanked Dr. Mark Cymerint for the email and CE provider application that he sent to the Board for review. She will have these materials available at the task force for open discussion.

#### Review and Discussion Regarding Proposed Outreach Publications

Dr. Dehn reviewed the Licensee Guide with the committee members.

On page 1, the committee recommended that the first and third paragraph under the chiropractic profession section be deleted.

On page 3, Dr. Dehn suggested the Board refer to the Top 10 Violation under the "show it off" section to remind chiropractors to "protect their license".

#### **Public Comment**

Dr. Cymerint referred to the material he sent to the Board and pointed out information about grandfathering CE providers and asked the committee members if they had any questions.

Mr. Puleo stated that since the materials were not included in the agenda they cannot be discussed but will have them available at the task force meeting for review and discussion.


#### **Future Agenda Items**

identify possible regulatory changes that will improve the educational experience by updating and streamlining chiropractic curriculum. This is an opportunity to modernize the current requirements to eliminating provisions that are redundant, obsolete, and inconsistent with 21st-century teaching models.

#### **Continuing Education**

In addition, the Board recently convened the first of two focus groups aimed at gathering continuing education (CE) providers and other stakeholders to develop standards for CE providers. In conjunction with CE providers, the Board wants to ensure that they are qualified and prepared to deliver quality CE to our licensees. The focus groups enable us to work closely with current providers to establish minimum requirements that achieve our goal of effective CE without being unnecessarily burdensome or restrictive. The next focus group will be held February 12, 2016, in Southern California.

#### **Antitrust Liability for Board Members**

Over the past couple of years, many of our licensees have expressed great concern over the Governor utilizing his executive powers to have the Board join all other health and regulatory boards in the Department of Consumer Affairs (DCA).

What was considered a controversial move has actually proven to be serendipitous given a recent U.S. Supreme Court ruling.

The recent U.S. Supreme Court decision in *North Carolina Board of Dental Examiners (North Carolina Dental) v. FTC* established a new standard for determining whether a state licensing board is entitled to immunity from antitrust actions. The Court held that a state regulatory board where a controlling number of decision makers are market participants (i.e., licensees) must satisfy the "active state supervision" requirement in order to invoke state-action antitrust immunity. Though there is no clear-cut definition of what constitutes active supervision, the California Attorney General's office issued an opinion that identifies a few requirements of active supervision. The opinion concluded that "active state supervision" requires a state official to review the substance of a regulatory decision made by the licensing board to determine whether the decision actually furthers

a clearly articulated state policy to replace competition with regulation. The opinion further stated that the official reviewing the decision must not be an active member of the profession being regulated and must have and exercise the power to approve, modify, or disapprove the decision.

Following the *North Carolina* decision, some observers have suggested that reforming the composition of professional boards would be the best resolution for both state and consumer interests. However, reducing the ratio of licensees to public members raises a number of logistical policy issues that would make this option problematic.

Fortunately, as currently structured, the Board through its relationship with DCA is in compliance with active State supervision requirements. DCA's oversight ensures that the Board's actions are consistent with clearly articulated State policies. As such, it is unlikely the Board will be subject to any modifications to its structure or composition.

#### **Chiropractic Occupational Analysis**

Currently, the Board is working with DCA's Office of Professional Examination Services to conduct an Occupational Analysis (OA). The purpose of the OA is to define the practice of chiropractic in California in terms of actual job tasks that newly licensed chiropractors must be able to perform safely and competently at the time of licensure. The results of the occupational analysis serve as the basis for the chiropractic licensing examination in California.

In early 2016, the Board will begin recruiting licensees to serve as Subject Matter Experts (SME) at one or more of the OA workshops. SMEs are essential to the OA process. A diverse group of SMEs ensures that all area of current practice and different approaches to practice are represented. Serving as an SME also gives licensees an opportunity to network with other chiropractors and provide direct input into the chiropractic profession. The results of the OA will affect decisions regarding the chiropractic profession and the licensure examination for up to eight years.

I encourage you to volunteer to serve as an SME when the Board begins recruiting. #### Earn CE Credit for Attending Our Board Meetings

The Board of Chiropractic Examiners' (Board's) regulations allow a licensee to earn a maximum of four hours of continuing education (CE) credit per renewal period for attending a full Board meeting that includes the hearing of cases related to petitioners seeking the reinstatement of revoked licenses or early termination of probationary licenses (California Code of Regulations, Title 16, section 361(g)15). A petitioner may not earn any CE hours for attending a Board meeting on the same day in which her or his hearing is conducted. The attendance of a licensee at a Board meeting under this regulation shall be monitored and confirmed by Board staff designated by the Executive Officer.

#### **Post Your License Proudly**

As chiropractors, you're aware of the rigorous requirements the Board of Chiropractic Examiners (Board) asks you to fulfill before it issues a license to practice in California—among them, comprehensive academic and clinical training, successful completion of national and State examinations, and a clean criminal background check.

We know the path to licensure may not be easy, but we believe you'd agree that California's chiropractors and their state regulatory board share a responsibility to ensure the health and well-being of patients of chiropractic care across the State.

We're confident that you will take this responsibility seriously.

We're also taking this opportunity to remind you that displaying your license is not only a well-deserved privilege but also a requirement under the Board's Rules and Regulations (California Code of Regulations, Title 16, section 308). Your license must be clearly visible to consumers at your place of practice, including any certificates issued for satellite offices.

You've earned the right to post your license proudly, and we encourage you to do precisely that. Displaying your license is more than compliance—it is our mutual pledge to provide continued excellence in chiropractic care to California's consumers.

#### **Tips for License Renewal**

On average, 8 percent of all license renewal applications are incomplete. Your license will not be updated appropriately until all the information and fees are received and complete. If the renewal delay causes your license to become delinquent, your ability to work is at risk. Follow these tips for a smooth renewal process:

- 1. Before starting the application, read through it thoroughly.
- 2. Make sure you complete all required continuing education hours prior to checking the appropriate checkbox and submitting your application and fee.
- 3. Check all appropriate boxes and sign the form.
- 4. Review your completed renewal application before you submit it.
- 5. Make sure your check or money order is for the correct amount.
- 6. Renew early.

The Board of Chiropractic Examiners (Board) sends renewal reminders about 60 days before a license expires. However, you are responsible to renew on time, even if you do not receive the reminder. A *Replacement Renewal Form* is on the Board's website at www.chiro.ca.gov/forms\_pubs/replace\_renewal.pdf.

#### Help Us Stay in Touch: Let Us Know if You Moved

Board of Chiropractic Examiners' (Board's) regulations require that licensed chiropractors in the State of California file with the Board a current address for each principal place of practice and for every associated satellite office (California Code of Regulations, Title 16, section 303). You must notify the Board within 30 days of new addresses for any places of practice.

If you're renewing your license, this will avoid critical delays in receiving your renewal notice or other important Board information.

Submit your address changes via U.S. mail or fax by completing the *Address Change Request* form, which is available on the Board's website at **www.chiro.ca.gov/forms\_pubs/add\_change.pdf**.

# A Guide to the Chiropractic Profession:

Getting licensed and staying licensed





#### The profession

Chiropractic is a health care profession that emphasizes the power of one's own body to heal itself without the use of drugs or surgery. The practice of chiropractic focuses on the relationship between structure (primarily the spine) and function (as coordinated by the nervous system), and how that relationship affects one's health.

#### Its future

Employment of chiropractors is projected to grow 15 percent from 2012 to 2022, faster than the average for all occupations, according to the U.S. Bureau of Labor Statistics. Also, more people are becoming interested in chiropractic care, since chiropractors use nonsurgical methods and do not prescribe drugs.

#### Getting licensed

If you're interested in a career as a chiropractor in California, you must meet the Board of Chiropractic Examiners' (Board's) strict requirements:

- Degree. You must receive a Doctor of Chiropractic (D.C.) degree from a Board-approved college.
   For a list of these colleges, go to the Board's website, www.chiro.ca.gov. The curriculum includes class time as well as clinical experience hours.
- NBCE. Chiropractic students must pass parts I, II,
  III, IV, and physiotherapy of the National Board of
  Chiropractic Examiners (NBCE) exam to be eligible to
  apply for a State license.



- Application. Complete the Application for a Chiropractic License, which must include your 2-inch-by-2-inch photograph. Be sure to use the Check Sheet for the Application for a Chiropractic License to ensure your application packet is complete. Both forms can be found on the Board's website, www.chiro.ca.gov.
- Fingerprinting. Live Scan is a process that scans your fingerprints electronically and is mandatory for applicants who are California residents. Take the Request for Live Scan Service form to a Live Scan site for fingerprint scanning. Out-of-state residents must submit fingerprint cards.
- Background check. California chiropractic license applicants must disclose all citations/arrests on your record—whether set aside, dismissed, or expunged in response to any direct question in any questionnaire or application for licensure.

- Fees. The standard license application fee is \$100.
   The reciprocal application fee is \$25. The Live Scan fingerprint services fees are paid directly to the Live Scan agency submitting the print. The fee to submit out-of-state fingerprint cards is \$49.
- CLPPE. The California Law and Professional Practice Exam (CLPPE) is administered through computerized testing on a continuous basis. Once the Board determines the licensee applicant is qualified to take the CLPPE, the applicant will be notified by letter.

More details regarding requirements can be found in the Board's Chiropractic Initiative Act and Chiropractic Examiners Rules & Regulations. Both can be found on the Board's website, www.chiro.ca.gov.

The average time for an initial review of your license application is three to four weeks. At that time, either a letter requesting more information or letter authorizing you to sit for the CLPPE will be sent. The average processing time for an application once received by the Board is three to five months.



#### Staying licensed

#### **Continuing education**

To maintain an active chiropractic license, D.C.s must complete 24 hours of continuing education (CE) per year. Six of the 24 hours are mandatory from the following categories:

- Two hours of Ethics and Law
- Four hours in any one of or combination of the following topics:
  - Chiropractic Adjustive or Manipulation Technique
  - History Taking and Physical Examination Procedures
  - Proper and Ethical Billing and Coding

Of the 24 hours, 18 hours may be completed in general subject categories, four hours of CE credit can be gained by attending a full Board meeting, and a maximum of 12 CE hours may be completed through distance learning.

#### License renewal

It is your responsibility to keep your license current. When renewing, do it early. Remember to read and review your completed form carefully, check all boxes, and sign the form. Also, be sure you complete all required CE hours prior to submitting the renewal form, and that your check or money order is for the correct amount. Incomplete renewal forms can cause a license to become delinquent, putting your ability to work at risk.

At this time, license renewals cannot be submitted online. Renewal forms are mailed to the address the Board has on file approximately 60 days prior to your license expiration date. If you did not receive your renewal form, you may print and complete a *Replacement Renewal Form* and mail it to our office.



Please note that the Board is required to deny an application for licensure and to suspend the license/certificate/ registration of any applicant or licensee who has outstanding tax obligations due to the Franchise Tax Board (FTB) or the State Board of Equalization (BOE) and appears on either the FTB's or BOE's certified lists of top-500 tax delinquencies more than \$100,000 (Assembly Bill 1424, Perea, Chapter 455, Statutes of 2011).

#### Show it off

Displaying your license is not only a well-deserved privilege, but also a requirement under section 308 of the Board's Chiropractic Examiners Rules & Regulations. Your license must be clearly visible to consumers at your place of practice, including any certificates issued for satellite offices.

#### Not worth it

Be aware of and understand the top licensee violations that may result in disciplinary actions. Frequent enforcement violations include:

- Insurance fraud
- Unlicensed practice
- Sexual misconduct
- Excessive treatment
- Violation involving drugs/alcohol
- Conviction of a crime
- False and/or misleading advertising
- Negligence/incompetence
