Call to Order

Dr. Azzolino called the meeting to order at 1:05 p.m.

Roll Call

Dr. Lubkin called the roll. All committee members were present.

Approval of January 30, 2013 Minutes

MOTION: DR. AZZOLINO MOVED TO APPROVE THE MINUTES

SECOND: DR. COLUMBU SECONDED THE MOTION

VOTE: 3-0

MOTION CARRIED

"Group-On" and Other Internet Marketing Sites-Business and Professions Code Section 650

Mr. Puleo spoke on "Group-On" and other internet marketing. He and Mr. Walker informed the Committee of a Department of Consumer Affairs' (DCA) released a legal opinion relating to this matter.

The Committee had a lengthy discussion.

MOTION: DR. LUBKIN MOVED TO ADOPT THE DCA LEGAL OPINION

SECOND: DR. COLUMBU SECONDED THE MOTION

VOTE: 3-0

MOTION CARRIED

The Committee had a further discussion.

MOTION: DR. LUBKIN MOVED TO SEND A LETTER TO GROUP-ON TO MAKE THEM AWARE OF THE LEGAL OPINION

The Committee discussed this motion further.

MOTION: DR. LUBKIN AMENDED THE MOTION TO POST THE DCA LEGAL OPIONION ON THE BOARD'S WEB SITE AND WAIVE THE ATTORNEY-CLIENT PRIVILEDGE SECOND: DR. AZZOLINO SECONDED THE MOTION

VOTE: 3-0

MOTION CARRIED

Mr. Walker indicated to confer with DCA to control the distribution. After a lengthy discussion, it was determined to present to the full Board at the May Board meeting to adopt DCA's legal opinion, post on the Board's web site, waive attorney-client privilege, direct Mr. Puleo to confer with DCA and notify Group-on.

Chiropractic Specialties-Status of Department of Industrial Relation Qualified Medical Examiner Eligibility Regulations

Dr. Lubkin and Mr. Puleo gave the history of this item. Dr. Azzolino directed Mr. Puleo to send another letter to the Department of Industrial Relations, Division of Workers' Compensation to inquire. If no response to the Board's letter, Mr. Puleo is to schedule a meeting to discuss.

Continuation of the Disciplinary Guidelines Review

The Committee proceeded to make changes to the Disciplinary Guidelines sections: Factors to Be Considered in Determining Penalties; Standard Conditions edited from 1/30/13 meeting; Optional Conditions

In reviewing the Disciplinary Guidelines, Mr. Puleo recommended to incorporate SB 1441 – Uniform Standards Regarding Substance-Abusing Healing Arts Licensees language into many of the proposed terms and conditions within the Disciplinary Guidelines (Attachment A and Attachment 1).

Incorporating Citations into the Disciplinary Guidelines

Mr. Walker indicated that citations are not considered formal discipline and can not be incorporated into the Disciplinary Guidelines. Citations and their process must be placed in the Board's Enforcement Procedure Manual.
