WHAT TO EXPECT FROM A CONTINUING EDUCATION AUDIT



The Board of Chiropractic Examiners (Board) conducts random continuing education (CE) audits to ensure compliance of renewing licensees. If you renewed your license in active status, you also certified you completed the CE requirements. This makes you eligible for an audit. Here is what to expect:

How will I know if I've been selected for an audit?

The Board will send a letter to your address of record informing you that you have been selected for an audit. The letter will include instructions on what action is required from you and what CE certificate documents are being requested. Make sure your address of record is current!

If I am selected for an audit, what do I need to submit to the Board and when?

You will need to submit copies of all documents verifying completion of the CE requirements. The Board will provide a deadline for submitting documents; generally allow two to three weeks to comply with an audit. Only submit CE documents if you have been selected for audit; do not submit them with your renewal.

How should I submit my documents?

Submit the audit request letter, along with copies of CE certificates or activities to the Board via fax at 916) 327-0039 or mail to 901 P St., Suite 142A Sacramento, CA, 95814.

What if I don't have all my documents?

The Board cannot count unverified courses or activities toward meeting the CE requirements. You must provide documentation to verify completion of hours for a successful audit. If you need copies of your CE documents, contact the CE course provider. Licensees and CE providers are required to maintain CE records for four years.

What if I did not complete all or part of my CE requirement?

If your audit is found deficient, it will be submitted to an enforcement analyst for further review. Any deficient audits will be subject to administrative action.

What if I need an extension to gather all my CE documents?

Please contact the Board at (916) 263-5355. An extension may be granted for gathering CE documents, but NOT for completing CE requirements.

What happens after I submit my documents?

A Board staff member will evaluate the materials you submitted and determine whether you met the CE requirements or not. A deficient audit will be sent to the Enforcement unit for further review. Instructions or actions taken by the Enforcement unit will be communicated to licensees via mail.

Reminder! Total hours required for each licensure period:

24 total hours:

- Ethics and Law—two hours.
- Four hours must be completed in any one of, or combination of, the following subject categories: history taking and physical examination procedures, OR chiropractic adjustive techniques, OR chiropractic manipulation techniques, OR ethical billing and coding.
- 18 hours may be taken in any of the categories listed in California Code of Regulations section 361, including the mandatory categories above.
- A maximum of 12 CE hours may be completed through distance learning.

Veterans Health Administration in Redding since 2005. He was owner at Active Care Chiropractic from 2002 to 2009 and was a chiropractic case manager at Professional Dynamics Corporation from 2004 to 2006. He was a chiropractic consultant for the State Compensation Insurance Fund from 2004 to 2006 and a qualified medical evaluator at the California Division of Workers' Compensation from 2002 to 2009 and from 2011 to 2013. He was a staff chiropractor for Sutter Health at Work Medical Associates from 2003 to 2005; a chiropractor at Redding Industrial Occupational Health from 2003 to 2004; associate doctor at Redding Chiropractic Clinic from 2001 to 2003; and an emergency medical technician at Goodhew Ambulance from 1989 to 1990. Paris completed the primary spine practitioner certification program at the University of Pittsburgh and is board certified with the American Chiropractic Rehabilitation Board. He is a member of the Council on Chiropractic Education Site Team Academy and the Chiropractic Clinical Guidelines and Practice Parameters Board. Paris is a past chair of the California Chiropractic Association's Governmental Affairs Committee and a member of the Veterans Health Administration's National Tele-Rehabilitation Advisory Board and National Chiropractic Field Advisory Committee. He is a member of the Foundation for Chiropractic Progress, the California Chiropractic Association, and American Chiropractic Association. Paris earned a doctor of chiropractic degree from Palmer College of Chiropractic.

Earn CE Credit by Attending a Board Meeting

Section 361(g)(15) of title 16 of the California Code of Regulations allows a licensee to earn a maximum of four hours of continuing education (CE) credit per renewal period for attending a full Board meeting that includes the hearing of cases related to petitioners seeking the reinstatement of revoked licenses or early termination of probation/reduction of penalty. A petitioner may not earn any CE hours for attending a Board meeting on the same day in which the petitioner's hearing is conducted. The attendance of a licensee at a Board meeting under this subparagraph shall be monitored and confirmed by Board staff designated by the executive officer.

IMPORTANT ANNOUNCEMENT

The Board of Chiropractic Examiners (Board) has adopted a new fee schedule based on the findings of a recent fee audit conducted by an independent auditing firm. The fee schedule was proposed in Senate Bill 1480 (Hill, Chapter 571, Statutes of 2018), which was approved by the California Legislature and signed by former Governor Jerry Brown on Sept. 19, 2018. The new fee schedule went into effect Jan. 1, 2019. Please familiarize yourself with the Board's new fees.

UPDATE: 2019 Regulations

Regulations

The Board of Chiropractic Examiners (Board) has completed or is actively working on the following regulatory proposals:

Application for Licensure and Continuing Education Requirements

This regulation expedites the licensure process for veterans, active military service members, and their families. In addition, this regulation amended the continuing education (CE) regulations to waive renewal fees, CE requirements, and other requirements for active duty members of the U.S. military. This regulation also allows the Board to award up to 16 hours of CE credit to licensees who participate in the review and revision of the California Law and Professional Practices Examination.

Effective Oct. 1, 2018.

Consumer Protection Enforcement Initiative

This regulation would add or amend 12 sections within the California Code of Regulations and establish stricter reporting and disclosure requirements by licensees and applicants. This regulation would also increase the Board's enforcement authority and access to critical information for use in investigations.

The initial review of this regulatory package has been completed by the Department of Consumer Affairs (DCA). The Board is currently working on revisions proposed by DCA's legal counsel and anticipates sending out a public notice in spring of 2019.

Revisions to the Board's Disciplinary Guidelines and Uniform Standards for Substance Abusing Licensees

The Board's "Disciplinary Guidelines and Model Disciplinary Orders" are being revised to streamline the enforcement process and provide greater protection to consumers. Additionally, the Board has incorporated the Uniform Standards into its disciplinary guidelines to ensure they are applied when a substance abusing licensee is disciplined.

This regulatory package is currently under development and the Board anticipates its submission to DCA for review in spring of 2019.

Delegation of Authority to the Assistant Executive Officer

This proposed regulation would delegate authority to the Board's assistant executive officer to execute specific enforcement actions and operational office functions in order to expedite the business of the Board, and to increase the health, safety, and welfare of consumers.

The initial review of this regulatory package has been completed by DCA. The Board is currently working on revisions proposed by DCA's legal counsel and anticipates sending out a public notice in spring of 2019.

Legislation Updates

Previous legislative session:

<u>Senate Bill 1480 (Hill, Chapter 571, Statutes of 2018)</u> <u>Professions and Vocations</u>

Effective Jan. 1, 2019, SB 1480 codified the Board's new fee schedule into section 1006.5 of the Business and Professions Code, where all the Board's fees can be easily found in one place. SB 1480 aligns the Board's revenue and expenditures, thereby ensuring a healthy fund condition and long-term sustainability of the Board.

<u>SB 1448 (Hill, Chapter 571, Statutes of 2018) Probation</u> <u>Status: Disclosure</u>

- Effective July 1, 2019, SB 1448 requires licensees of the Board, who have been placed on probation on or after July 1, 2019, to disclose their probationary status to all patients. Additionally, licensees are required to obtain a signed copy of a written disclosure from each patient prior to their first visit.
- SB 1448 requires the Board to provide specified information related to licensees on probation in plain view on the licensee's profile page on the Board's website.

<u>Assembly Bill 2138 (Chiu/Low, Chapter 995,</u> <u>Statutes of 2018) Denial of Application: Revocation or</u> <u>Suspension Licensure: Criminal Conviction</u>

Effective July 1, 2020, AB 2138 restricts the Board's discretion in using prior criminal history as grounds for licensing determinations and establishes new prohibitions relating to the denial, suspension, and revocation of licensure. Additionally, the bill requires the Board to develop new denial criteria and imposes new reporting requirements.

Patient Notification of Probation Status

On Sept. 19, 2018, SB 1448 (Hill— Healing Arts Licensees: Probation Status: Disclosure), known as the "Patient's Right to Know Act of 2018," was signed into law and will require specified health care professionals, including licensed chiropractors who have been placed on probation <u>on or</u> <u>after July 1, 2019</u>, to disclose their probationary status to all patients.

Effective **July 1, 2019**, SB 1448 requires licensees of the Board to provide the following information on a written disclosure to patients:

- The licensee's probation status.
- The length of the probation, including the probation end date.
- The term(s) and condition(s) of probation, including all practice restrictions placed on the licensee by the Board.
- The Board's telephone number and a brief explanation of how the patient can find further information about probationary conditions or causes for probation on the Board's website on the licensing details page.

Furthermore, SB 1448 requires licensees to obtain a signed copy of a written disclosure from each patient prior to their first visit.

To assist licensees in complying with the provisions of SB 1448, the Board will develop a patient notification form. However, licensees are not required to use the Board's form and may develop their own disclosure form when this law takes effect.
