Common Violations and Helpful Tips to Keep Your License in Good Standing

1. Renew Your License on Time

You must renew your license each year in order to practice chiropractic. In order to maintain an active license, you must submit your renewal payment to the Board of Chiropractic Examiners (Board) every year prior to the expiration date of the license and complete the continuing education (CE) requirements. Practicing with an expired license is considered *illegal practice* (California Code Regulation, Title 16, section 312). If you have any questions about the license renewal process or CE requirements, contact the Board's Licensing Unit at (916) 263-5355.

Failing to renew your license timely or practicing with an expired license can have many unintended consequences. When you don't renew on time, you will have to pay late fees in addition to the license renewal fee. If you allow your license to remain expired for a period of three consecutive years, you must either meet the CE requirements to restore your license, have practiced in another state under an active valid license and completed all CE requirements for that state, or pass the National Board of Chiropractic Examiners (NBCE) Special Purposes Examination for Chiropractic within six months prior to submitting your application for restoration of your license with the required fees (California Code of Regulations, Title 16, section 371(g)). In addition to late fees, violations of section 312 of Title 16 of the California Code of Regulations or Chiropractic Initiative Act could include paying a citation/ fine or even administrative penalty (if disciplinary action is taken against your license). Beyond your licensing board, you may also find yourself exposed to additional liabilities or sanctions for services you conducted or billed for while your license was expired.

2. Be Responsive to Requests to Release Chiropractic Patient Records and Maintain Chiropractic Records

Upon written request from a patient or his/her representative, you must release the patient's records within 15 business days of receiving the request. Section 123110 also specifies fees that you may charge for copying the requested records. You may not withhold records because of an unpaid bill for services (Health and Safety Code, section 123110 (b), (j)).

California Code of Regulations, Title 16, section 318 (a), requires that patient records must be made available to the Board with the patient's written consent or a valid legal order. Active patient records must be immediately available to the Board upon request. Inactive patient records must be available to the Board within 10 days upon request. Patient records, whether inactive or active, must be maintained for five years from the date of the doctor's last treatment of the patient.

3. Ensure Chiropractic Patient Records Are Compliant With Board Rules

California Code of Regulations, Title 16, section 318, requires all patient records to include:

- (1) Patient's full name, date of birth, and Social Security number (if available);
- (2) Patient gender, height, and weight. An estimated height and weight is acceptable where the physical condition of the patient prevents actual measurement;
- (3) Patient history, complaint, diagnosis/analysis, and treatment must be signed by the primary treating doctor. Thereafter, any treatment rendered by any other doctor must be signed or initialed by said doctor;
- (4) Signature of patient;
- (5) Date of each and every patient visit;
- (6) All chiropractic X-rays, or evidence of the transfer of said X-rays;
- (7) Signed, written informed consent as specified in section 319.1. Treatment must be signed by the patient and the primary treating doctor. Records that are illegible and incomplete or that do not support all billing may result in corrective or disciplinary action.

4. Make Sure Billing Is Done Properly

Make sure your treatment records and services appropriately and adequately support your billing and billing codes. Under California Code of Regulations, Title 16, section 318(b), overcharging a patient or billing for services not rendered, may result in corrective action or disciplinary action. In the event that an error results in overbilling, reimbursement must be made within 30 days after discovery or notification of the error.

5. Practice Within Your Scope of Practice

All diagnoses and treatment provided under your license must be within your scope of practice, per California Code of Regulations, Title 16, section 302. The fact that you have learned a procedure in school or at a seminar, or you have been properly trained in the performance of a technique or procedure, does not mean that it is within your scope of practice.

6. Notify the Board of Address Changes Within 30 Days

California Code of Regulations, Title 16, section 303, requires licensees to provide the Board with a current address for their primary place of practice and for each and every satellite office. In addition, licensees are required to notify the Board in writing of any and all changes to the practice address, giving both the old and new address, within 30 days of that change.

7. Conduct on Premises

As a chiropractor, you are responsible for inappropriate, unprofessional, or illegal conduct by the employees or other persons working at your place of practice, even when you are not physically present (California Code of Regulations, Title 16, section 316).

8. Display Your License

California Code of Regulations, Title 16, section 308, requires a licensee to display a current active license in a conspicuous place in the licensee's primary place of practice. A licensee also must display, in a conspicuous place, a current active Satellite Office Certificate at the office for which it was issued.

9. Advertise Legally and Appropriately

Be sure your advertising is in compliance with California Code of Regulations, Title 16, section 311, and Business and Professions Code section 651. Please be aware that it is a violation of section 15 of the Chiropractic Initiative Act if you don't use "D.C." following the use of "Dr." in your advertising materials, letterhead, or business cards. The Board cannot provide legal advice or give direction regarding your advertising; therefore, it is recommended that you consult a private attorney for assistance in this area.

Simple communication and follow up goes a long way toward continuing a successful practice. Often times, many complaints received by the Board are submitted by patients as a result of a miscommunication or misunderstanding with the licensee. A simple conversation or regular communication with a patient is an effective, proactive way to ensure that the patient is aware of and understands treatment, diagnoses, billing, office procedures, etc.

Earn CE Credit for Attending Our Board Meetings

The Board of Chiropractic Examiners' (Board's) regulations allow a licensee to earn a maximum of four hours continuing education (CE) credit per renewal period for attending a full Board meeting that includes the hearing of cases related to petitioners seeking the reinstatement of revoked licenses or early termination of probationary licenses (California Code of Regulations, Title 16, section 361(g)(15)). A petitioner may not earn any CE hours for attending a Board meeting on the same day in which said petitioner's hearing is conducted. The attendance of a licensee at a Board meeting under this regulation shall be monitored and confirmed by Board staff designated by the Executive Officer.

— On January 24, 2014, a regulatory package was proposed in response to Assembly Bill 2699 (Bass, Chapter 270, Statutes of 2010), which would allow out-of-State chiropractors to volunteer their services at sponsored free health care events in California. This package was disapproved by the Office of Administrative Law (OAL) on March 5, 2015; however, the Board of Chiropractic Examiners (Board) is actively working to meet the administrative requirements to pass this regulation. The Board anticipates the resubmittal of this regulation in June 2015 for approval by OAL.

Legislative:

— Business and Professions Code (BPC) section 30 was amended through Senate Bill 1159 (Lara, Chapter 752, Statutes of 2014), which requires boards within the Department of Consumer Affairs (DCA) to accept an individual taxpayer identification number or a Social Security number from applicants who are individuals applying for licensure. Individual applicants who do not have a Social Security number are required to provide the Board with an individual taxpayer identification number. A regulation package will be proposed in 2015 to update the application for licensure for compliance with these requirements. However, the Board is accepting applications with either a Social Security number or individual tax identification number effective immediately.

— BPC section 114.3 was enacted through AB 1588 (Atkins, Chapter 742, Statutes of 2012) and requires boards under DCA to waive the renewal fees, continuing education requirements, and other renewal requirements for any licensee or registrant called to active duty as a member of the U.S. Armed Forces or the California National Guard. The Board was not part of DCA at the time this law was enacted but was later moved under DCA as part of the Governor's Reorganization Plan, which resulted in a conflict with the Board's regulation (California Code of Regulations section 364(h)). A regulation package will be proposed in 2015 to address this conflict.

Registering as a Professional Corporation

Information below is based on frequently asked questions and the most common mistakes made when completing the Certificate of Registration for Chiropractic Corporation application and/ or when forming a professional chiropractic corporation.

Naming Requirements

The name of a chiropractic corporation must comply with the California Business and Professions Code section 1054, which provides that "Notwithstanding any other provision of law, the name of a chiropractic corporation and **any name or names under which it may be rendering professional services**, shall contain the name or the last name of one or more of the present, prospective, or former shareholders, and shall include the word 'chiropractic' and the word 'corporation,' or wording or abbreviations denoting corporate existence."

You may not file or use a fictitious name or "doing business as" name for the corporation. The corporate name must appear on all checks, business cards, flyers, advertisements, etc.

Corporate Officers and Directors

These offices are dependent on the number of shareholders of the corporation. For example, if there is only one shareholder, he or she must be listed as both the president and treasurer as a minimum. When there are two shareholders, they will split the four offices as per Corporations Code section 13403. Vice president and secretary need not be licensed; however, they may not be shareholders. The shares must total 100 percent.

Employees

List all licensees who will render professional services, even if they are already listed as corporate officers or shareholders.

Attachments

Along with the application, include a copy of the Endorsed Articles of Incorporation from the Secretary of State, along with any amendments, listing the corporation as a "Professional Corporation" within the meaning of Part 4, Division 3, Title 1, of the California Corporations Code. The Articles must be filed as a Professional Corporation.

Any corporation filed as General Corporation Law or as an "S," "C," or "LLC" will be returned to applicant and must be amended with the Secretary of State. Failure to include a copy of the Endorsed Articles of Incorporation will result in your application being returned.

Fee and Processing Time

The fee to register a chiropractic corporation with the Board is \$100. This fee is nonrefundable, and the processing time is three to four weeks.

Reporting Requirements

Pursuant to California Code of Regulations, Title 16, section 367.10(b), each chiropractic corporation shall file a special report within 30 days of any change of the corporate officers/directors, shareholders, employees rendering professional services, and articles of incorporation. Include corporation name change (not change of ownership) or change of corporate practice address on this form. Each special report filed must be accompanied by a \$5 filing fee. To download a copy of the application, go to the Board's website, **www.chiro.ca.gov**.
